





# WHAT IS A CASA VOLUNTEER?



## CASA OF FLOYD COUNTY

When a child enters the foster care system because his or her home is no longer safe, a judge may appoint a committed volunteer to help them. That volunteer is called a Court Appointed Special Advocate®, or CASA.


- Are background checked and HIGHLY TRAINED
- Are APPOINTED BY A JUDGE to represent and advocate for a child's best interests in the child welfare system
- Serve as the "EYES AND EARS" of the court
- RESEARCH each child's situation
- Make OBJECTIVE RECOMMENDATIONS to help each child reclaim their childhood from abuse and neglect
- Are frequently the ONLY STABLE PRESENCE in the child's life as they navigate the foster care system
- Save taxpayers money and children's futures by helping children find SAFE, PERMANENT HOMES where they can thrive

# WHO ARE CASA VOLUNTEERS?

CASA volunteers are people just like you compassionate and self-motivated individuals from the community. They come from all backgrounds and walks of life. They are passionately committed to make a difference in the life of a child entangled in an overburdened foster care system.







